CITIZEN SCIENCE MONITOR INTERNSHIP

Department: Pit River Environmental Programs Office
Duration: 2 Week Paid Internship Training
Work Schedule: 8 hrs. Per Day- Temporary Paid Training

Internship Summary:

The Pit River Tribe's Environmental Department received funding under a Tribal Wildlife Grant to support science research and habitat restoration. The two primary objectives for this project, were to engage habitat and wildlife conservation. First, the project will establish an autonomous long-term (>10 year) wildlife monitoring program through recruitment, education and work force training of Tribal members; particularly youth. This project will demonstrate how multi-partner collaborations, habitat restoration and citizen science can be combined to enhance conservation of native habitat and wildlife on Tribal lands and application across greater spatial scales (e.g., western Great Basin).

Qualifications/ Experience:

This position requires interest in and background or understanding of science concepts related to ecological restoration, Traditional Ecological Knowledge (TEK) and ecology or wildlife. Ability to collaborate with volunteers and staff. Ability to work outdoors and traverse mountainous and rugged terrain. Knowledge and or interest in Northern California native flora and fauna. Ability to manage time schedules and follow direction.

Other Duties Include:

- Coordination with IERC Biologists on wildlife research, citizen science monitoring techniques to support environmental and natural resources protection in line with the Tribe's Environmental Planning and protection goals and research objectives.
- Maintaining communication with the Pit River Tribe Tribal Wildlife Grant Leads in Alturas.

- Ability to work collectively with staff, IERC Biologists, facilitators, and other participants.

Indian Preference:

Preference given to qualified Native Americans under the Federal Indian Preference Act (43CPR17.3 [d]). Applicants claiming Indian Preference must submit verification of Indian certification by tribe of affiliation or other acceptable documentation of Indian heritage.

Note: *This position requires an awareness and deep appreciation of the Pit River Tribal Indian tradition, customs, and socioeconomic need. It requires the ability, at all times, to meet and deal effectively in contacts with Indian people and organizations. This requires tact, courtesy, confidentiality, discretion, resourcefulness, and good judgment in handling sensitive issues.*
